



Application for Admittance to the Louisiana Delta Community College Paramedic Program

2024-2025 Cohort

Admission to the Louisiana Delta Community College Paramedic Program is competitive. Completed applications that are remitted with all mandatory criteria and supporting documentation are given preference on a first come first served basis. Provisional acceptance may occur if space permits and requires an approved application with the mandatory criteria met. Individuals who apply and are not initially accepted will be placed on a waiting list in case a vacancy occurs. Only 20 students may be accepted into a cohort. Students must maintain their eligibility to practice as EMTs throughout the program or they will be dismissed from the program. To be accepted into the Louisiana Delta Community College Paramedic Program, you must meet the following mandatory criteria:

1. Be admitted as student to Louisiana Delta Community College (LDCC). Applications for admission to LDCC can be found at <http://www.Eadelta.edu/Admissions/Apply/apply>. Louisiana Delta Community College ensures equal opportunity for all qualified individuals without regard to race, color, religion, sex, national origin, age, political belief, disability, marital status, or veteran's status in admission to or participation in, its programs and activities. If a student believes that he/she has been discriminated against on the basis of race, sex (including sexual harassment), religion, color, national or ethnic origin, age, disability, or military service, that student should report the matter to the Dean of Student Success Services, who will seek to assist the student with resolution of the complaint as described in the complaint procedure. Louisiana Delta Community College will provide reasonable special service and accommodations for students with learning or physical disabilities. Students desiring to self-identify may complete a Special Needs Assessment Form, which can be obtained in the Department of Student Success Services
2. Be currently registered as a Nationally Registered EMT or higher AND be currently licensed as an EMT or higher by the Louisiana Bureau of Emergency Medical Services. Both the National Registry of EMTs and the BEMS have set criteria for certification and licensure as a paramedic.

Acceptance as a student does not ensure approval from either entity to receive any special considerations for certification or licensure. Students with disabilities are highly encouraged to examine the policies of the NREMT and BEMS and contact them if questions prior to applying for admission to the program. Copies of both certification and licensure numbers are required.

3. Have passed with at least a "C" or higher the prerequisite Bio 221 and Bio 223 Human Anatomy and Physiology with a lab* (Course substitutions based on transcripts and/or previous learning experience will be considered on an individual basis; Biol110 and 111 are approved for TD in Paramedic).
4. Must be able to pass a Random Drug Screen and Background check, throughout the duration of the program.
5. The following supporting documentation is needed in addition to the application and mandatory criteria to receive preference on admission:
6. Apply and be accepted as an EMS (ALS) student by the Louisiana Bureau of EMS. Copy of valid driver's license
 - Copy of current BLS/CPR card
 - Copy of health insurance card
 - Physician statement or physical examination attesting to the candidate's physical ability to perform the job requirements of a paramedic dated within the past 12 months.
 - You will also have to pass a state and federal background check \$60.00.
 - Documentation of the following immunizations:
 1. MMR
 2. Tdap
 3. Hepatitis B series
 4. Varicella
 5. Influenza
 6. TD booster within last 10 years
 7. Titers of Varicella, Rubella, Hepatitis
 8. Documentation showing TB Skin test result within the past 12 months. Copy of X-ray results if test is positive.
 9. Covid vaccination card or written declination of vaccine
